 - iii. Potential unveiling date – Friday, May 15th and open to public for Founders Day.

 - i. Virtual Art Walk will take approximately 6 months to complete,– these may not meet ordinances, will have to review.
 - f. Art & Sculpture Walk – add to next months agenda per committee.
 - i. Virtual Art walk, Artist Spotlight Project, and History Alive Project – these may not meet ordinances, will have to review.
 - ii. Virtual Art Walk will take approximately 6 months to complete.
